**Motion:** Larry moved to recommend that the Board approve 221, 222, 720, 731 and 771.1 with the modification listed above. Rita Greshik seconded the motion. Motion passed 4-0.

Policy 834 and 834.1 (Facility Use): Discussion was held on the need to make the school accessible to the community while also being mindful of the cost/benefit to the district resources. There are several groups who use the facility which provide intangible benefits to the school; others provide donations to the school or pay for certain services. Recently, a for-profit group asked to use the facilities. The current facility use policy does not address for-profit groups or other groups beyond those listed on the policy. Since it has been some time since the policy was reviewed and since some of the groups that use the school are uncertain of their status in relation to the school, it would be helpful to review the use of the school, the cost to the school and the benefits that the school and the outside groups receive from the school use. This will also provide an opportunity to better understand the relationship between the outside groups and the school, i.e., what do those groups need/want from the school and how do they see themselves benefitting the school. Luke will gather data on the costs of the facilities' use by outside entities

as well as the contributions that those facilities have made to the school. Then those groups will be asked for input.
