The district WILL have a Community Programs and Service Fund (Fund 80) for the 2023-2025 fiscal years. The district does not intend to exceed the limit on the Fund 80 levy authority imposed by 2013 Wisconsin Act 20 for the 2023-2025 fiscal years.

The Cochrane-Fountain City School District Community Service Fund consists of three main programs: Preschool program, Hall of Fame recognition, and Community Newsletter. These programs were established to support, celebrate, and inform our community youth and adults. The expenses incurred by these programs are funded through fees and the local tax levy. The Board of Education approves a local property tax levy which entirely funds all of the listed community service programs except for the Preschool program which is additionally funded through user fees and/or donations. Budgeted revenues and expenditures (which include compensation of personnel, maintenance and custodial services, equipment, and supply purchases for programming) from the district's Fund 80 are as follows for the fiscal year July 1, 2023 – June 30, 2025:
