1. Summer Food Program. We can continue free meals until June 30th but after that, because we are not 50% free/reduced, we cannot run a free summer lunch program for all.

2. On to College – ACT Prep. This is an ACT prep program that we purchased to help juniors. The program is being used mostly in English class but also in the other content areas.

3. ESSER II grant. We are expected to get \$ 228,310 to spend on COVID related expenses. We have 2 years to spend the money. We are leaning towards another counselor for the next 2 years.

4. Teach grant. We were awarded \$30,000 which will be integrated into the e-rate discount resulting in \$100,000 worth of technology upgrades over 5 years. All wireless access points will be updated, and license renewed.
